#### **Municipal Elections Act Requirements**

#### Electors and candidates with disabilities

• **12.1** (1) A clerk who is responsible for conducting an election shall have regard to the needs of electors and candidates with disabilities.


### By-laws re voting and vote-counting equipment, alternative voting methods

42 (1) The council of a local municipality may pass by-laws,
(a) authorizing the use of voting and vote-counting equipment such as voting machines, voting recorders or optical scanning vote tabulators;
(b) authorizing electors to use an alternative voting method.

**By-law 2005-135** provides for the use of tabulators in Kitchener municipal elections.

#### Voting Methods Investigation

- Corporate Risk Assessment
- Reliability of the optical scan vote tabulators for the past 5 municipal elections
- High satisfaction rate (90%) from the 2022 voter exit survey
- Other programs that could leverage paper ballots and tabulators



#### **Online/Internet Voting Considerations**

- Accessible to electors that cannot attend an in-person voting location
- Technical and security infrastructure reliance outside of City control by private vendors
- Threat actors posing security risks with tampering or hacking of system
- No legal framework and limited standards

Limited accountability for service delivery impacts



#### Vote By Mail Considerations

• Accessible to electors that cannot attend an in-person voting location

 Third-party dependency (Canada Post) potentially resulting in inability to deliver/return ballots, prolonged return times, resulting in delivery of ballots beyond deadline.

 High and increasing postage costs related to the mailing and returning of ballots.

 Voter confusion, possible, affecting the ability to ensure that all votes are cast as intended



#### Paper Ballots / Tabulators Considerations

- Accessible Ballot Marking devices present at locations to allow electors to independently mark a ballot
- Curbside voting at a Voting Locations permitted for accessibility
- Configured and tested through publicly available Logic and Accuracy Testing procedures (Vote Count Procedures)
- Not connected to the internet and physical results tapes produced verified against tabulator memory cards



# Home Vote Program (upon request) (Proposed)

• Implemented in 2022 in Cambridge, Brampton, Vaughan, Markham, Guelph, and for the 2022 and 2018 election by Oakville

 Support eligible voters who are unable to come to an in-person voting location due to illness, injury or disability

 Electors can mark their ballot from their residence, which is brought to them by election officials (registration and appointment is required) and then tabulated through a vote count tabulator



#### Drive Thru Voting (Proposed)

- Implemented in 2022 in Cambridge and Windsor
- Eligible voters attend a designated drive thru voting location and remain in vehicles until prompted to drive up to the registration desk (ID verification) then parks at a designated spot and all voters receive a ballot inside a secrecy sleeve and vote within the privacy of the vehicle
- Voters then place their ballot in the ballot box presented to them at their window and then tabulated through a vote count tabulator
