OF THE

CORPORATION OF THE CITY OF KITCHENER

(Being a by-law to Amend City of Kitchener By-law 2024-01,  
Chapter 553 and Chapter 599 of the City of Kitchener  
Municipal Code with respect to a System of Administrative  
Monetary Penalties within the City of Kitchener)

WHEREAS the Council of the Corporation of the City of Kitchener has enacted By-law 2024-01, being a By-law relating to a System of Administrative Monetary Penalties for Violations of City of Kitchener Non-Parking By-laws;

AND WHEREAS the Council of the Corporation of the City of Kitchener has enacted Chapter 553 (Lodging Houses) of the City of Kitchener Municipal Code to regulate the operation of Lodging Houses within the City of Kitchener;

AND WHEREAS the Council of the Corporation of the City of Kitchener has enacted Chapter 599 (Licensing and Regulation of Businesses) of the City of Kitchener Municipal Code relating to the licensing of various businesses within the City of Kitchener;

AND WHEREAS the Council of the Corporation of the City of Kitchener deems it desirous to amend By-law 2024-01 to provide for the use of Administrative Monetary Penalties for Chapter 553 (Lodging Houses) and Chapter 599 (Licensing and Regulation of Businesses);

AND WHEREAS the Council of the Corporation of the City of Kitchener deems it desirous to amend Chapter 553 (Lodging Houses) and Chapter 599 (Licensing and Regulation of Businesses) of the City of Kitchener Municipal Code to provide for the use of Administrative Monetary Penalties;

NOW THEREFORE the Council of the Corporation of the City of Kitchener enacts as follows:

1. Schedule "A" of City of Kitchener By-law 2024-01 is hereby amended by inserting the tables contained in Appendix "A" to this By-law, therein.
2. Article 8 of Chapter 553 of the City of Kitchener Municipal Code is amended by deleting sections 553.8.1 and 553.8.2 and replacing the two sections with the following:

**"553.8.1**

Any Officer may enter onto the Premises at all reasonable times and in accordance with any applicable requirements in the *Municipal Act, 2001*, as amended, to inspect any Lodging House in respect of which a Person is required to be licensed under this Chapter.

### **553.8.2**

No Person shall hinder or obstruct, or attempt to hinder or obstruct, any Officer exercising a power or performing a duty under this Chapter.”

3. Article 11 of Chapter 553 of the City of Kitchener Municipal Code is amended by deleting sections 553.11.3 and 553.11.4 and replacing the two sections with the following:

#### **“553.11.3**

All the provisions of this by-law continue to apply in the *Provincial Offences Act* in addition to the designated provisions of this by-law.

#### **553.11.4**

Sections 553.2.2, 553.3.5, 553.3.6, 553.7.8, 553.8.2 and 553.9.4, inclusive of all subsections thereunder, of this Chapter are hereby designated as parts of this Chapter to which the Administrative Penalty By-law applies.”

4. Article 12 of Chapter 553 of the City of Kitchener Municipal Code is hereby amended by inserting the following section therein:

#### **“553.12.3**

Where a person has not paid the administrative penalty within 30 days in accordance with the Administrative Penalty By-law, the City may add the administrative penalty to the tax roll for any property for which the owner or owners are responsible for paying the administrative penalty under Section 553.11.5.”

5. Article 1 of Chapter 599 of the City of Kitchener Municipal Code, as amended, is hereby amended by adding the following definitions thereto:

#### **“599.1.1.1**

“Administrative Penalty By-law” means the Administrative Penalty System for Non-Parking By-laws, By-law Number 2024-001 of the City, as amended from time to time, or any successor thereof;

#### **599.1.28.1**

“Designated provision” means any section of this Chapter designated in accordance with Section 599.14.4.”

6. Article 14 of Chapter 599 of the City of Kitchener Municipal Code, as amended, is hereby amended, by adding the following subsections thereto:

#### **“599.14.3**

No person shall hinder or obstruct, or attempt to hinder or obstruct, any Officer exercising a power or performing a duty under this Chapter.

#### **599.14.4**

Sections 599.3.1, 599.4.5, 599.7.4, 599.8.7, 599.11.3, 599.12.4, 599.14.3, and Schedules 4, 5, 6, 7, 9, 11, 12, 13, 14, 15, 16, 17, 18, 19, 21, 22, 23, 24, 25, 26 and 27, inclusive of all subsections thereunder, of this Chapter are hereby designated as parts of this Chapter to which the Administrative Penalty By-law applies.

#### **599.14.5**

Any person who contravenes any Designated Provision of the Chapter shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any administrative fees, in accordance with the Administrative Penalty By-law.

#### **599.14.6**

All the provisions of this by-law continue to apply in the *Provincial Offences Act* in addition to the designated provisions of this by-law.

#### **599.14.7**

Where a person has not paid the administrative penalty within 30 days in accordance with the Administrative Penalty By-law, the City may add the administrative penalty to the tax roll for any property for which the owner or owners are responsible for paying the administrative penalty under Section 599.14.5.”

7. The Clerk of the City is hereby directed to make the By-law \_\_\_\_\_ a part of The City of Kitchener Municipal Code by adding it to the concordance and arranging and numbering it as a chapter so as to fit within the scheme of the Municipal Code
