<u>CORPORATION OF THE CITY OF KITCHENER</u> <u>NATURAL GAS</u> FIRM INDUSTRIAL AND COMMERCIAL CONTRACT RATE – M4

Applicability

To a customer who enters into a contract for a minimum term of one year, that specifies a daily contracted demand (CD) as follows:

Between 2,400 m³ and 140,870 m³.

<u>Rate</u>

1. Bills will be rendered monthly and shall be the total of:

i) A Fixed Demand Charge:

First	8,450 m ³ of the daily contracted demand,	63.9000 ¢/m ³

2. Over-run Charge

Authorized overrun gas is available provided that it is authorized by the Corporation in advance. The Corporation will not unreasonably withhold authorization. Overrun means gas taken on any day in excess of 103% of contracted daily demand. Authorized overrun will be available April 1 through October 31, and will be paid for at the rate of 4.5813 ¢/m³ for the delivery and, if applicable, the federal carbon charge and the total gas supply rate of 20.85 ¢/m³.

Unauthorized overrun in any month shall be paid for at the rate of 9.2371 ϕ/m^3 for the delivery and, if applicable, the federal carbon charge and the total gas supply charge for system-supplied volumes at the rate of 20.85 ϕ/m^3 .

3. Minimum Annual Charge

In each contract year, the customer shall purchase from the Corporation or pay for a minimum volume of gas equivalent to 150 days use of contracted demand. Overrun gas volumes will not contribute to the minimum volume. In the event that the customer shall not take such minimum volume, the customer shall pay an amount equal to the deficiency from the minimum volume times a rate of 2.497 ϕ/m^3 , and if applicable, a total gas supply charge of 20.85 ϕ/m^3 .

In the event that the contract period exceeds one year, the annual minimum volume will be pro-rated for any part year.

Applicability

To a Customer who:

- A) Enters into a contract for a minimum term of one year that specifies a daily contracted demand between 2,400 m³ and 140,870 m³ inclusive and,
- B) Has an alternate fuel supply and combustion system available.

<u>Rate</u>

2. Over-run Charge

Overrun gas is available provided that it is authorized by the Corporation in advance. The Corporation will not unreasonably withhold authorization. Overrun means gas taken on any day in excess of 105% of contracted daily demand.

Unauthorized overrun gas taken in any month shall be paid for at the rate of 9.2371 e/m^3 for the delivery and, if applicable, the federal carbon charge and the total gas supply charge for system-supplied volumes at the rate of 20.85 e/m^3 .

Unauthorized Overrun Non-Compliance Rate:

Unauthorized overrun gas taken any month during a period when a notice of interruption is in effect shall be paid for at the rate of 234.72 e/m^3 (\$60 per GJ) for the delivery.

3. Minimum Annual Charge

In each contract year, the customer shall purchase from the Corporation or pay for a minimum volume of gas equivalent to 150 days use of contracted demand. Overrun volumes will not contribute to the minimum volume. In the event that the customer shall not take such minimum volume, the customer shall pay an amount equal to the deficiency from the minimum volume multiplied by 4.0299 ¢/m³ for the delivery charge and if applicable, a gas supply charge of 20.85 ¢/m³.

Gas purchased under this rate shall not be resold, directly or indirectly by the customer.
