The Ministry of Transportation (MTO) has completed its review of the proposed works at 2480 Homer Watson Boulevard. The plan has been considered in accordance with the Public Transportation and Highway Improvement Act (PTHIA), MTO's Highway Corridor Management Manual (HCMM) and all related guidelines and policies. The following outlines our comments:

The subject property is in close proximity to Highway 401, a Class 1A - Freeway with a posted speed of 100 km/hr, and is designated as a Controlled Access Highway. As such, all requirements, guidelines and best practices in accordance with this classification and designation shall apply.

The owner should be aware that the property falls within MTO's Permit Control Area, and as such, MTO Permits are required before any demolition, grading, construction or alteration to the site commences. In accordance with the Ontario Building Code, municipal permits may not be issued until such time as all other applicable requirements (i.e.: MTO permits/approvals) are satisfied. As a condition of MTO permit(s) MTO will require the following for review approval:

## **Building and Land Use Permit**

A MTO Building and Land Use Permit is required. As a condition of MTO permits, the following shall be provided:

 The Proponent shall submit an acceptable Site Plan, and Site Servicing Plan for MTO review and approval. These plans shall clearly identify all structures/works (existing and proposed).
